D. Bridge work is almost complete at WOW Park
E. The Kemp project will be completed ahead of time. All projects should be completed within 18-19 months from the start of the project.
F. The Rails to Trails benches and water fountains will be installed soon.
G. The plan for Bert Harsh is developing. This park will be programmed mostly by the library, and there is an entirely different pool of grants to look at for funding. We hope to have things like sensory gardens and music features.

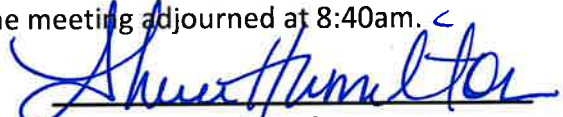
