 - A. Municipal Grant discussion –Sheree Hamilton informed the Authority of the suggestions for a MOU with the City of Doerun for the Playground project. Sheree Hamilton will present at the next meeting.
 - B. Community Day- Maggie Davidson stated that Councilman Posey informed the City council of the lack of interest and participation in the informational meeting that was held for Community Day. Community Day will be cancelled this year but will be revisited again with interested parties at the table for planning.
 - C. Tennis Court Dates –Bids have been sent out for the resurfacing project. Bids are due June 6, 2022.

The pools will be open in June. Maggie Davidson showed photos of the renovated bathroom floors and discussed the Summer Programs. The Golden Olympics registration is open for people over 50. E-sports is underway and summer registration is open. A Meet the Pack event is being discussed with the football coach. Boys and Girls Club is still occupying the R.D. Smith Youth Center with programs planned for the summer.
